

Cooke County Electric Cooperative Scholarship Application

Twelve scholarships are available in the amount of \$1,000 each. This will be subject to confirmation that the requirement of enrollment has been met.

Eligibility:

1. Ten scholarships will be made available to active members and their immediate families living full time in residences (residential metering only) receiving service from Cooke County Electric Cooperative Association.
2. Members of the board, General Manager, scholarship administrator, employees and their immediate families (per CCEC Employee Policy #335) are eligible for two scholarship to be randomly drawn by the scholarship selection committee following the selection of the ten scholarship winners.
3. Scholarships to be granted to attend a recognized institution of higher education (college, technical school, or other post-secondary educational institution).
4. Applicant must be of good character as evidenced by at least three (3) letters from teachers, principals, counselors, etc., from the school they are attending. For applicants returning to school after an extended absence, letters will be accepted from previous employers, supervisors, ministers, etc.
5. Applicant must demonstrate a coherent degree plan and willingness to pursue a course of higher learning.
6. Scholarships will be awarded on the basis of funds available and the applicants' eligibility.
7. Applications must be received no later than Friday, March 05, 2010. Awards will be announced within ten (10) days of this date.
