

2011 Government in Action Youth Tour Contest

Cooke County Electric Cooperative holds a contest each year to select a participant for Texas Electric Cooperatives Government in Action Youth Tour. The trip is an extremely special one. By tradition and intent, the tour is set up to give youth an in-depth look at the nation's capital. Youth will meet their Legislator, tour dozens of interesting sites and learn a great deal about history, government and electric cooperatives.

Those who have taken the trip say what really makes it special are the relationships they build with other outstanding young people from around the state. The TEC provides excellent chaperones and leaders.

The tour has been a turning point in the lives of some. Former U.S. Rep. Bill Sarpaluis quietly vowed to return to Washington after he took the tour as a high school senior. Another former tour participant is Fred McLure, who served as Special Assistant for Legislative Affairs for President George Bush, Sr.

Cooke County Electric Cooperative pays travel expenses (\$2,250) including meals and lodging. Winners need only money for snacks, souvenirs, film and personal items.

Contest Guidelines:

Eligible participants must be a high school junior or senior. Students must live in a home currently served by Cooke County Electric Cooperative and his/her parent(s) or guardian must be a CCEC member with an active **residential** account. Past winners, children, or grandchildren of CCECA Directors and Employees are not eligible.

Entrants must deliver the essay to the Cooperative office by **5:00 P.M. on Friday, February 11, 2011**. The essay must be an original composition by the student with the length being **500 words or more** (typed and doubled spaced). The topic this year should be very easy. **All you have to do is tell us why you would be a great Cooperative representative on the Youth Tour.** It's that easy!

Essays should include a cover page with information required. (See Page 2) For purposes of judging, the essay itself and inside pages should carry only one identification mark: the student's Social Security number in the upper right hand corner of the page.

A panel of qualified judges will select five finalists. On Sunday, **March 06, 2011, the five finalists will be interviewed by a panel of three judges.** This interview will allow the finalists the opportunity to convince the judges of their leadership qualities. The winner will be awarded the trip to Washington and other finalists will receive a prize. Judges will name a runner-up. The runner-up is important, and will be asked to go on the tour in the event the winner cannot.
